GUIDE TO BECOMING A VENDOR

1. Fill out attached application (either farmer or artisan or both).
2. Review East Texas FRESH Association Rules and Regulations and Bylaws. These documents are posted on [easttexasfresh.com](http://easttexasfresh.com). Copies can be obtained by emailing [easttexasfresh@yahoo.com](mailto:easttexasfresh@yahoo.com).
3. Insure that you meet the criteria for becoming a vendor and obtain any licenses or permits required to sell your products.
4. Determine what category of vendor you intend to apply for:
  - Day Vendor- A vendor who has been approved to sell at the market and pays the application fee and a \$25 weekly stall fee but does not wish to vote or hold a reserve space at the market.
  - Member Vendor- A vendor who pays the application fee, a membership fee, a \$20 weekly stall fee and has voting rights and a reserved space at the market.

**\*\*Application fee** (non-refundable) - \$25

**\*\*Membership fee** - \$50

5. Complete application and submit with payment.
